## COMMUNIQUÉ FIRST INTERNATIONAL ECONOMIC AND HUMANITARIAN FORUM UKRAINIAN ID



JULY 7, 2018, CHERNECHA MOUNTAIN, KANIV

We, the participants of the 1st International Economic and Humanitarian Forum Ukrainian ID, united at the event in Kaniv on the basis of a common understanding of the future of the humankind and the ways and laws on which moderm society should evolve.

We consider freedom and the possibility of personal development as the basis of the successful State and successful economy.

Today in the world, human capital is the foundation of the most significant economic achievements. The success of the entire countries in our age of radical social and technological changes on the planetary scale depends on the access of everyone to the cultural, educational and scientific infrastructure, to the possibilities of knowledge and creative development.

And every country in our time must ensure the humanitarian rights of citizens for the sake of their own existence.

The historical period in which we live has risen the fundamental challenges to the usual way of life, the traditional activities of people, enterprises and States. Functions of the state apparatus are already transferred to telephone applications, and the functions of workers - to robots. No country will be able to escape these global transformations, regardless of its current economic status or technological development.

A radical change in the whole economic model will require us to either evolve or marginalize, or even disappear.

Therefore, only those societies will be able to step into the future, where the development of a person is considered to be the highest value, and its provision - the priority task of social and economic policies.

Within the framework of the international dialogue here in Kaniv, we identified the main global challenges in the areas of economics, human security, community-development, culture and technology. As a result of our work, we propose a roadmap through which Ukraine and world powers can build a successful common global future.

We appeal to world and local governments. In order not to turn the population of your countries into an archaic instrument of capital extraction, whose value in the age of technological change is rapidly falling, we propose to develop and consolidate a new meaning for human life.

At the level of national or local legislation, humanitarian security of the individual, access to humanitarian infrastructure must be declared the main values and objects of protection. In this context, we propose to the Government and Parliament of Ukraine:

- 1. To introduce an amendment to the third article of the Constitution of Ukraine that the right to humanitarian development is recognized as the highest social value, and to the seventeenth article the definition of humanitarian security as a component of national security of the State.
- To impose a nationwide moratorium on the elimination and redefinition of extracurricular cultural, educational, artistic and sports facilities. This norm should be introduced in the Constitution of Ukraine and in all laws concerning decentralization and self-governance.
- To introduce in the package of laws on decentralization the norm that at least 20% of the budgets of Ukrainian communities should be invested in the development of human capital. For breach of this rule, responsibility must be established;
- 4. Create a National Development Program that builds the actions of ministries and other State institutions around the preservation and enhancement of humanitarian capital;
- 5. To define one of the global priorities of the State:
- 1) to build a high-quality tourism infrastructure, including roads, laying water and airways, an efficient logistic map which would allow Ukrainians and citizens from all over the world to get to the unique monuments of our history, culture and architecture; 2) preservation and popularization of the cultural heritage;
- 3) establish for criminal officials and related citizens criminal liability for the destruction and loss of objects of cultural and historical importance.

We are appealing to the investors, who move the global economy forward, to knowingly invest resources in those projects that have the main or ancillary consequence of the development of human capital. And, at the same time, refraining from supporting such projects that have a negative impact on communities and personalities - affect the quality of life, access to education and culture, create ecological dangers and destroy the historical heritage of humankind.

Many countries of the world have the laws stipulating the responsibility for harmful actions committed to a person or society. However, economic interests often prevail over these laws or prudence. Nevertheless, if today we do not put humanitarian interests at the heart of any economic activity, the world and ukrainian economy will collapse as colossus without reliable support - as has happened many times during the crises of the XX and XXI centuries.

Therefore, we turn to the representatives of the investment business, who is responsible for the development of the entire industries, countries and regions of the world, to develop ethical rules within the investment community, as well and responsibilities for those who violate these rules.

We proclaim a special appeal to the leaders of Ukrainian political movements on the eve of the presidential and parliamentary elections of 2019.

None of the leaders of the Ukrainian State or government set the rights and opportunities of humanitarian development of a person in the basis of their activities. The priority of the Ukrainian State during the independence period was the attainment of at least stable economic performance. But this, which showed our new history, is not enough. It is

human and humanitarian security that should be a priority objective and, at the same time, a guarantor of the State's existence.

We appeal to you, in case of your victory in the next year's election, to accept the following obligations:

- To make humanitarian development and multiplication of human capital a top priority of the State and local politics in Ukraine;
- 2. Tackle the corruption without any compromises. It is a burden and a subject to zero tolerance in the international transparent economy;
- **3.** To guide Ukraine to the future in a free global world without returning to totalitarian or authoritarian governance.

The International Economic and Humanitarian Forum Ukrainian ID, its founders and participants will carry out the work on the implementation of all these goals in order to implement humanitarian values in the policy of the states.

Our next meeting will be held in Kaniv in the summer of 2019.
